Psychiatric Inpatient Services Founded: 1970

Organizational Structure: Charitable, not-for-profit, community-owned hospital, has been a member of Parkview Health since 1997. In 2018, Parkview acquired Park Center, a Community Mental Health Center (CMHC), and Parkview Behavioral Health Institute was created to expand services in the community.

Beds: 105 inpatient beds and 30 residential substance abuse disorder beds

SERVICES/FACILITIES

Crisis Services

- Parkview Psychiatric Emergency Services, located inside Parkview Hospital Randallia, provides crisis evaluations for Parkview Health.
- HelpLine is a 24-hours-a-day service in which experienced specialists complete confidential assessments and guide callers to the appropriate level of care or community resources as needed.
- Assessment Center and Intake Services, located at 909 East State Boulevard campus. Walk-ins are welcome.
- The SOS Mobile Intervention Team provides experienced specialists to provide mental health crisis intervention when someone is in a heightened state of crisis, providing resources, a safety plan, and further assessment.
- The Crisis Stabilization Unit is available to individuals who are experiencing an acute mental health or substance use crisis. This service is suitable for those who do not require intensive medical care and can be stabilized within 23 hours.

Acute Inpatient Services

- Parkview Behavioral Institute has 105 beds and provides acute psychiatric inpatient services to children, adolescents, and adults.



Outpatient Psychiatric and Therapeutic Services

- Parkview Physicians Group (PPG) provides psychiatric services in Allen, Adams, Wabash, Wells, and Huntington Counties, including treatments for children, dementia, depression, eating disorders, PTSD, and seasonal affective disorder.
- Intensive Outpatient Programs are available in Allen, Adams, and Huntington Counties. Services for adolescents and adults include mental health and substance use disorders. Programs run three days per week for several weeks, depending on individual treatment needs.

Addiction Treatment

- Parkview, in collaboration with its community mental health center, Park Center, offers Outpatient Addiction Medication Services (MAT) for opioid use and substance use disorders in Allen, Adams, Huntington, Wabash, and Wells Counties.
- Outpatient programs are available in Allen, Adams, Wells, and Huntington Counties to help with addiction. Programs are based on the American Society of Addiction Medicine (ASAM) criteria that serve adult men and women. Care providers include a team of board-certified addictionologists, therapists, and licensed addiction counselors.
